





According to the 2010 Census, Charlotte County had the second highest median age of any U.S. county with a population of more than 100,000 people at 55.9. Its county seat is Punta Gorda, Florida, and also includes the unincorporated towns of Port Charlotte and Englewood. Port Charlotte was named to Forbes' list of "25 Best Places to Retire in 2015". Charlotte County's cost of living is slightly lower than the state average. Major private-sector employers include Walmart, Bayfront Health, and Publix Supermarkets. 

The cost of living in Sarasota County is just higher than the state average. For the fourth consecutive year, Sarasota County has been recognized by the Florida Department of Health as a Healthy Weight Community Champion for 2016. Major private-sector employers include Publix Supermarkets, Venice Regional Medical Center, PGT Industries, and FCCI Insurance Group. Sarasota County has a dental health care shortage for their Low Income Populations (North Port/South Venice, Sarasota Service Area). The climate remains warm throughout the year, with a high of 71 in January (low of 49), and a high of 91 in July (low of 73).
