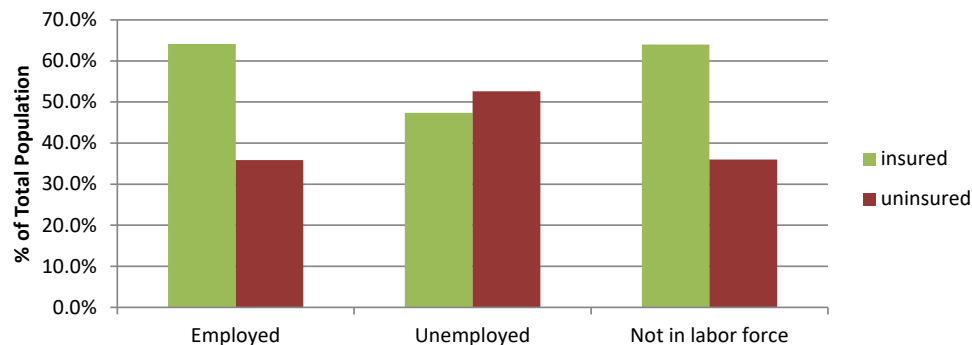

## **DeSoto County, Florida**

DeSoto County includes Arcadia, which is its county seat. A rural county, DeSoto has a population density of 54.7 people per square mile, as compared to Florida's average of 350.6 people per square mile. DeSoto County is ranked second for Physical Environment according to the County Health Rankings, and its level of air pollution is better than that of top U.S.

performers. In 2017, DeSoto County was recognized as a Healthy Weight Community Champion. The cost of living in DeSoto County is lower than the state average. DeSoto County has a primary care health shortage for their Low Income/Migrant Farmworker Population, a dental health care shortage for their Low Income/Migrant Farmworker Population (DeSoto), and a mental health care shortage for the entire county. The climate remains warm throughout the year, with a high of 71 in January (low of 49) and a high of 91 in July (low of 73).

## Charlotte County, Florida

According to the 2010 Census, Charlotte County had the second highest median age of any U.S. county with a population of more than 100,000 people at 55.9. Its county seat is Punta Gorda, Florida, and also includes the unincorporated towns of Port Charlotte and Englewood. Port Charlotte was named to Forbes' list of 25 Best Places to Retire in both 2015 and 2017. Charlotte County's cost of living is 6% lower than the national average. Charlotte County has a primary care health shortage for their low income population, and a dental health care shortage for their low income population (Port Charlotte). The climate is warm year-round, with a high of 74 in January (low of 53) and a high of 91 in July (low of 74). In Charlotte County, 88% of the population has adequate access to locations for physical activity. In 2017, Charlotte County was recognized as a Healthy Weight Community Champion.
